2607 FOLSOM STREET, Lot 12D in Assessor's Block 3639 in a RH-3 Zoning District, the Calle 24 SUD, and a 40-X Height and Bulk District.

REAR YARD VARIANCE SOUGHT: The proposal is to legalize the replacement of the second and third floor rear decks in-kind, and to build a new rear staircase in a new footprint.

PLANNING CODE SECTION 134 requires a rear yard equal to 45% of the lot depth, or the average of adjacent buildings up to a maximum 25% of the lot depth. The decks and stairs to proposed to be legalized obstruct into the required rear yard. Therefore, a variance is required.

All items listed hereunder constitute a Consent Calendar and are considered to be routine by the Zoning Administrator. 1033 TEXAS STREET, Lot 036 in Assessor's Block 4224 in an RH-3 Zoning District and a 40-X Height and Bulk District

REAR YARD VARIANCE SOUGHT: The project proposes to raise and move forward the existing three-story, two-family structure approximately 8 feet to allow for an additional story and to better relate the building to its topographic setting. The project would also remove an existing rear addition and replace it with a new rear addition in roughly the same footprint.

PLANNING CODE SECTION 134 requires the property to maintain a rear yard equal to 25% of the lot depth. However, the proposal will obstruct approximately 10 feet into the required 25% rear yard. Therefore, a variance is required.

REAR YARD VARIANCE SOUGHT: The project proposes a horizontal rear expansion at the second floor, a deck at the third floor, and a rear stair structure, for the existing single-family structure.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of 30% (27 feet). The proposed addition will obstruct approximately 4 feet into the required rear yard. Therefore, a variance is required.

FRONT SET BACK VARIANCE SOUGHT: The proposal is to reconstruct an existing front egress stair and portion of an existing garage structure, and to add new railings and front gate.

PLANNING CODE SECTION 132 requires the subject property to maintain a front setback of approximately 8 feet. The current stair configuration encroaches entirely into the front setback. The reconstructed stair would be replaced within the same footprint. Therefore, the project requires a variance.

144 BONVIEW STREET, Lot 014 in Assessor's Block 5619 in a Residential House - One Family (RH-1) Zoning District, Bernal Heights SUD, and a 40-X Height and Bulk District.

REAR YARD & MASS REDUCTION VARIANCES SOUGHT: The project proposes a vertical and horizontal addition to an existing three-story, 1,564-square-foot, single-family structure that would result in a four-story, 3,248-square-foot, single-family structure. New rear decks are proposed for the second and fourth floor.

PLANNING CODE SECTION 242(e)(2) requires the property to maintain a rear yard equal to 35 percent of the total lot depth, which is 24.5 feet for the subject lot. The proposed structure will obstruct into the required rear yard. Therefore, a variance is required.

PLANNING CODE SECTION 242(e)(3) requires a total of 650 square feet of usable floor area to be deleted from the exterior of the building, causing a reduction in square footage as well as building volume. Only 216 square feet of usable floor area is proposed be deleted from the exterior of the building. Therefore, a variance is required.

REAR YARD VARIANCE SOUGHT: The project proposes to legalize an 8.5-foot by 17.75-foot one-story rear addition as part of a new ground floor dwelling unit located behind the existing commercial space.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of 25% (25 feet). The rear addition to be legalized is 15 feet 7 inches from the rear property line. Therefore, the project requires a variance.

REAR YARD VARIANCE SOUGHT: The project proposes to: 1) Infill an area at the basement level beneath an existing deck; 2) Expand the third floor on the south side; 3) Replace the side deck in the same location with no change in size; and 4) Replace in-kind the existing noncomplying portion of the building located in the rear yard.

PLANNING CODE SECTION 134 requires a rear yard equal to 45% of the lot depth, or the average of adjacent buildings up to a maximum 25% of the lot depth. The existing noncomplying building extends to within 3 feet 9 inches of the rear property line. Therefore, a variance is required.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of 25% (15 feet). The new building will fully encroach into the rear yard. Therefore, the project requires a variance.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of approximately 54 feet. The rear deck completely encroaches into the required rear yard. Therefore, the project requires a rear yard variance.

1120 VALENCIA STREET, Lot 004 in Assessor's Block 3635 in a Valencia NCT (Valencia Street Neighborhood Commercial Transit) Zoning District and a 55-X Height and Bulk District.

REAR YARD VARIANCE SOUGHT: The proposal is to construct a five-story, 55-foot-tall mixed-use building on an existing surface parking lot with ground floor Retail/Restaurant use along Valencia Street and 18 residential units above.

PLANNING CODE SECTIONS 134 requires the subject property to maintain a rear yard equal to 25 percent of the lot depth at the lowest story containing a dwelling unit, and at each succeeding level or story of the building, which is between 18 feet 6 inches and 20 feet 6 inches given the irregular lot shape. The proposed new building will cover the entire lot. Therefore, the project requires a rear yard modification.

320 RITCH STREET, Lot 036 in Assessor's Block 3787 in a CMUO (Central SOMA Mixed Use Office) Zoning District, Central SoMa SUD, and a 65-X Height and Bulk District.

ACTIVE USE VARIANCE SOUGHT: The project proposes to change 3,439 square feet of PDR use to Office use on the ground floor. There are no physical changes proposed as a part of this project.

PLANNING CODE SECTIONS 145.1 and 249.78 require the ground floor space on Ritch Street to contain Active Uses within the first 10 feet of building depth. Office use is not considered an Active Use in the Central SoMa SUD. Therefore, a variance is required.

At this time, members of the public may address the Zoning Administrator on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator except agenda items. With respect to agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached in the meeting. Each member of the public may address the Zoning Administrator for up to three minutes.

The Zoning Administrator will not take action on any item not appearing on the posted agenda, including those items raised at public comment. In response to public comment, the Zoning Administrator may:

- (1) respond to statements made or questions posed by members of the public; or
- (2) request staff to report back on a matter at a subsequent meeting; or
- (3) direct staff to place the item on a future agenda. (Government Code Section 54954.2(a))

Notice

The Planning Department has moved to a new office. Since August 17, 2020, the Planning Department is now located at **49 South Van Ness Avenue, Suite 1400**.

Hearing Procedures

The **Zoning Administrator** typically holds Variance Hearings on the **4th Wednesday of each month at 9:30 a.m.**, at the **San Francisco City Hall, Room 408**. However, due to Covid-19 and in compliance with the Shelter-In-Place Order in San Francisco, the Zoning Administrator has been holding his monthly Variance Hearings remotely using Video and Teleconferencing since April 2020.

At the hearing, the **Project Sponsor** (Variance Applicant) will be given 5 minutes to present their case, including relevant testimony and evidence. The hearing room is equipped with a projector that can display photographs, architectural plans or other drawings and images. **Members of the public** will be given 3 minutes each to speak on the item. If a member of the public speaks against an item, the Project Sponsor will be given a 3-minute **rebuttal**.

Persons attending a hearing may comment on any scheduled item. When speaking, please note that a **timer** is used for each speaker and indicates how much time remains. Speakers will hear a notification indicating that the speaker's opportunity to address the Zoning Administrator is about to end or has ended.

Please note that some items may appear on the **Consent Calendar**. These items are considered routine and may be granted by the Zoning Administrator. There is no separate discussion of consent items unless the Zoning Administrator, member of the public or staff so requests, in which event the matter is removed from the Consent Calendar and will be moved to the Regular Calendar in the Agenda.

In addition, the Zoning Administrator may consider a request for **continuance** to a later date. He may choose to continue the item to the date proposed, to continue the item to another date, or to hear the item on this calendar.

After all the testimonies are submitted, the Zoning Administrator will consider the evidence, deliberate, and either make a decision, take the matter under advisement, or continue the matter in order for additional information to be presented.

Each hearing ends with **general public comment**, at which time members of the public may address the Zoning Administrator for up to 3 minutes on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator, except agenda items. With respect to Agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached during the meeting.

All Agenda of Variance Hearings and its Audio Recording (from June 2010 to present) are available on our website for access.

Sound-Producing Devices Prohibited

The ringing of and use of mobile phones and other sound-producing electronic devices are prohibited at this meeting. Please be advised that the Zoning Administrator may order the removal of any person(s) responsible for the ringing or use of a mobile phone, pager, or other similar sound-producing electronic devices (*67A.1 Sunshine Ordinance: Prohibiting the use of cell phones, pagers and similar sound-producing electronic devices at and during public meetings*).

Decision Letter and Appeal Process

No decision is final until a **Variance Decision Letter** is issued. Due to current backlogs, decision letters may take **up to 2 months** to complete from the date of the hearing. The Zoning Administrator's action to grant or deny a variance application may be appealed to the Board of Appeals within **10 days** of the date of the Decision Letter. If any members of the public would like to receive a copy of the signed Variance Decision Letter via email, please send a request by email addressed to the Planner assigned to the case. The name of the Planner can be found in this Agenda, in the notice that you received in the mail, or in the poster posted on the subject property.

Protest of Fee or Exaction

You may protest any fee or exaction subject to Government Code Section 66000 imposed as a condition of approval in accordance with Government Code Section 66020. The protest must satisfy the requirements of Government Code Section 66020(a) and must be filed within 90 days of the date of the first approval or conditional approval of the development referencing the challenged fee or exaction. For purposes of Government Code Section 66020, the date of imposition of the fee shall be the date of the earliest discretionary approval by the City of the subject development.

The Zoning Administrator's approval or conditional approval of the development subject to the challenged fee or exaction as expressed in its Motion, Resolution, or Discretionary Review Action or the Zoning Administrator's Variance Decision Letter will serve as Notice that the 90-day protest period under Government Code Section 66020 has begun.

Challenges

Pursuant to Government Code Section 65009, if you challenge, in court, (1) the adoption or amendment of a general plan, (2) the adoption or amendment of a zoning ordinance, (3) the adoption or amendment of any regulation attached to a specific plan, (4) the adoption, amendment or modification of a development agreement, or (5) the approval of a variance, conditional-use authorization, or any permit, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Administrator or Planning Commission, at, or prior to, the public hearing.

CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code

If the Zoning Administrator's or Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. This appeal is separate from and in addition to an appeal of an action on a project. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. If the Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at <http://www.sf-planning.org/index.aspx?page=3447>. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

Privacy Policy
