## **Accessible Meeting Policy**

Hearings are held at **City Hall, 1 Dr. Carlton B. Goodlett Place, Room 408, Fourth Floor**, San Francisco, CA 94103. The closest accessible BART Station is the Civic Center Station located at the intersection of Market, Hyde, and Grove Streets. Accessible curb side parking has been designated at points along McAllister Street. Members of the public are not required to provide personal identifying information when they communicate with the Planning Department and its commissions. All written or oral communications that members of the public submit to the Department regarding projects or hearings will be made available to all members of the public for inspection and copying. The Department does not redact any information from these submissions. This means that personal information including names, phone numbers, addresses and similar information that a member of the public elects to submit to the Department and its commissions may appear on the Department's website or in other public documents that members of the public may inspect or copy.

**242 32ND AVENUE**, Lot 016 in Assessor's Block 1391, in an RH-1(D) Zoning District, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The project proposes to 1) expand the dormer windows on the single-family building at the rear of the lot, 2) expand the basement level, 3) replace the front porch, 4) excavate at the front and rear to create lightwells down to the basement level, 5) demolish the existing garage at the front of the lot, and 6) construct a new, larger garage in the same location.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard depth of 45 feet. The existing house, and the proposed dormer expansion, is fully within the required rear yard. Therefore, a variance is required.

**REAR YARD VARIANCE SOUGHT:** The proposal is to relocate the existing building to the front of the lot, add vertical and horizontal additions, and make facade alterations.

PLANNING CODE SECTION 134 requires properties the subject lot to maintain a rear yard of 18 feet, however the project proposes little to no rear yard. Therefore, a variance is required.

**591-595 WALLER STREET**, Lot 020 in Assessor's Block 0865, in an RTO Zoning District, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is a horizontal expansion of the 2nd and 3rd floor to add an elevator at the rear of the building.

PLANNING CODE SECTION 134 requires that the property maintain a rear yard that is 45% of the lot depth or average of adjacent buildings, but in no case less than 25% or 15 feet, whichever is greater. The rear expansion of the 2nd and 3rd floor is located entirely in the required rear yard. Therefore, a variance is required.

**1201 32ND AVENUE**, Lot 001 in Assessor's Block 1718, in an RH-1(D) Zoning District, and a 40-X Height & Bulk District

**REAR YARD AND SIDE YARD VARIANCES SOUGHT:** The proposal is to construct a second story horizontal addition measuring 46 square feet at the rear and 10 square feet at the side to an existing 2-story residential building containing 3 dwelling units.

PLANNING CODE SECTION 133 requires the subject property to maintain two side yards of approximately 3 feet each. The proposed horizontal addition extends 10 inches into the required south side yard. Therefore, the project requires a variance.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of approximately 27 feet. The proposed horizontal addition is located entirely within the required rear yard. Therefore, the project requires a variance.

**19 PORTER STREET**, Lot 014 in Assessor's Block 5808, in an RH-2 Zoning District, The Bernal Heights SUD, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is to construct a rear deck at the 2nd story of the existing 2-story single-family building.

PLANNING CODE SECTION 242 requires the subject property to maintain a rear yard of approximately 31 feet 6 inches measured from the rear property line. The existing house already encroaches roughly 3 feet into the required rear yard. The proposed deck will encroach approximately 4 feet 10 inches further into the required rear yard. Therefore, the project requires a variance.

**55 ULLOA STREET**, Lot 039 in Assessor's Block 2902, in an RH-1(D) Zoning District, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is to construct a vertical addition to an existing two-story, single-family building.

PLANNING CODE SECTION 134 requires the subject property to maintain a rear yard of approximately 26 feet 5 inches measured from the rear property line. The existing building extends into the required rear yard. A portion of the proposal would expand the building within the required rear yard. Therefore, a variance is required.

**200-214 VAN NESS AVENUE**, Lot 203 in Assessor's Block 0811, in a C-3-G Zoning District, and a 96-X Height and Bulk District

**BICYCLE PARKING VARIANCE SOUGHT:** The proposal is to reduce the amount of Class 1 Bicycle Parking spaces from 166 to 64 in the existing building containing 113 student group housing bedrooms, 30 dwelling units, 49,600 square feet of educational and performance space, and 2,600 square feet of ground floor restaurant/retail space.

PLANNING CODE SECTION 155.1(b)(3)(B) requires that no more than one-third of the required Class 1 bicycle parking be provided as Vertical Bicycle Parking. The project proposes 64 total spaces, 26 of which are Vertical Bicycle Parking. Therefore, a variance is required.

PLANNING CODE SECTION 155.2 requires the Project to provide 166 Class 1 bicycle parking spaces (30 for the dwellings; 134 for student housing; 2 for Institutional Uses; and 1 for retail uses). The project proposes only 64 Class 1 bicycle parking spaces. Therefore, a variance is required.

**888 FELL STREET**, Lot 067 in Assessor's Block 0822, in an RM-1 Zoning District, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is to construct a deck at the rear of the building.

PLANNING CODE SECTION 134 requires properties the subject lot to maintain a rear yard equal to 45 percent of the total lot depth, unless reduced to the average of qualifying adjacent rear building walls, but not less than 25 percent or 15 feet, whichever is greater. The proposed deck is located within the last 25 percent of lot depth. Therefore, a variance is required.

**C. PUBLIC COMMENT:**

At this time, members of the public may address the Zoning Administrator on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator except agenda items. With respect to agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached in the meeting. Each member of the public may address the Zoning Administrator for up to three minutes.

The Zoning Administrator will not take action on any item not appearing on the posted agenda, including those items raised at public comment. In response to public comment, the Zoning Administrator may:

- (1) respond to statements made or questions posed by members of the public; or
- (2) request staff to report back on a matter at a subsequent meeting; or
- (3) direct staff to place the item on a future agenda. (Government Code Section 54954.2(a))

**Hearing Procedures**

The **Zoning Administrator** typically holds Variance Hearings on the **4<sup>th</sup> Wednesday of each month at 9:30 a.m.**, at the **San Francisco City Hall, Room 408**. City Hall is located at One Dr. Carlton B. Goodlett Place, San Francisco, CA 94102. Hearings are open to the public.

At the hearing, the **Project Sponsor** (Variance Applicant) will be given 5 minutes to present their case, including relevant testimony and evidence. The hearing room is equipped with a projector that can display photographs, architectural plans or other drawings and images. **Members of the public** will be given 3 minutes each to speak on the item. If a member of the public speaks against an item, the Project Sponsor will be given a 3-minute **rebuttal**.

Persons attending a hearing may comment on any scheduled item. When speaking, please note that a **timer** is used for each speaker and indicates how much time remains. Speakers will hear a notification indicating that the speaker's opportunity to address the Zoning Administrator is about to end or has ended.

Please note that some items may appear on the **Consent Calendar**. These items are considered routine and may be granted by the Zoning Administrator. There is no separate discussion of consent items unless the Zoning Administrator, member of the public or staff so requests, in which event the matter is removed from the Consent Calendar and will be moved to the Regular Calendar in the Agenda.

In addition, the Zoning Administrator may consider a request for **continuance** to a later date. He may choose to continue the item to the date proposed, to continue the item to another date, or to hear the item on this calendar.

After all the testimonies are submitted, the Zoning Administrator will consider the evidence, deliberate, and either make a decision, take the matter under advisement, or continue the matter in order for additional information to be presented.

Each hearing ends with **general public comment**, at which time members of the public may address the Zoning Administrator for up to 3 minutes on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator, except agenda items. With respect to Agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached during the meeting.

All Agenda of Variance Hearings and its Audio Recording (from June 2010 to present) are available on our website for access.

**Sound-Producing Devices Prohibited**

The ringing of and use of mobile phones and other sound-producing electronic devices are prohibited at this meeting. Please be advised that the Zoning Administrator may order the removal of any person(s) responsible for the ringing or use of a mobile phone, pager, or other similar sound-producing electronic devices (*67A.1 Sunshine Ordinance: Prohibiting the use of cell phones, pagers and similar sound-producing electronic devices at and during public meetings*).

**Decision Letter and Appeal Process**

No decision is final until a **Variance Decision Letter** is issued. Due to current backlogs, decision letters may take **up to 2 months** to complete from the date of the hearing. The Zoning Administrator's action to grant or deny a variance application may be appealed to the Board of Appeals within **10 days** of the date of the Decision Letter. If any members of the public would like to receive a copy of the signed Variance Decision Letter via email, please send a request by email addressed to the Planner assigned to the case. The name of the Planner can be found in this Agenda, in the notice that you received in the mail, or in the poster posted on the subject property.

**Protest of Fee or Exaction**

You may protest any fee or exaction subject to Government Code Section 66000 imposed as a condition of approval in accordance with Government Code Section 66020. The protest must satisfy the requirements of Government Code Section 66020(a) and must be filed within 90 days of the date of the first approval or conditional approval of the development referencing the challenged fee or exaction. For purposes of Government Code Section 66020, the date of imposition of the fee shall be the date of the earliest discretionary approval by the City of the subject development.

The Zoning Administrator's approval or conditional approval of the development subject to the challenged fee or exaction as expressed in its Motion, Resolution, or Discretionary Review Action or the Zoning Administrator's Variance Decision Letter will serve as Notice that the 90-day protest period under Government Code Section 66020 has begun.

**Challenges**

Pursuant to Government Code Section 65009, if you challenge, in court, (1) the adoption or amendment of a general plan, (2) the adoption or amendment of a zoning ordinance, (3) the adoption or amendment of any regulation attached to a specific plan, (4) the adoption, amendment or modification of a development agreement, or (5) the approval of a variance, conditional-use authorization, or any permit, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Administrator or Planning Commission, at, or prior to, the public hearing.

**CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code**

If the Zoning Administrator's or Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. This appeal is separate from and in addition to an appeal of an action on a project. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at <http://www.sf-planning.org/index.aspx?page=3447>. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

**Privacy Policy**

SF Planning is committed to protecting the privacy rights of individuals and security measures are in place to protect personally identifiable information (PII), i.e. social security numbers, driver's license numbers, bank accounts. Members of the public are not required to provide PII to the Commission or Department, as all written submittals and oral communications become part of the public record, which can be made available to the public for review and/or viewable on Department websites. Members of the public submitting materials containing PII are responsible for redacting said sensitive information prior to submittal of documents to Planning.
