## Accessible Meeting Policy

Hearings are held at **City Hall, 1 Dr. Carlton B. Goodlett Place, Room 408, Fourth Floor**, San Francisco, CA 94103. The closest accessible BART Station is the Civic Center Station located at the intersection of Market, Hyde, and Grove Streets. Accessible curb side parking has been designated at points along McAllister Street. Accessible MUNI Lines serving City Hall are the 42 Downtown Loop, 9 San Bruno and 71 Haight/Noriega, and the F Line. Accessible MUNI Metro Lines are the J, K, L, M, N, and T. ## Know Your Rights under the Sunshine Ordinance

Government's duty is to serve the public, reaching its decisions in full view of the public. Commissions, boards, councils and other agencies of the City and County exist to conduct the people's business. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.

Personal information that is provided in communications to the Planning Department is subject to disclosure under the California Public Records Act and the San Francisco Sunshine Ordinance. Personal information provided will not be redacted.

Members of the public are not required to provide personal identifying information when they communicate with the Planning Department and its commissions. All written or oral communications that members of the public submit to the Department regarding projects or hearings will be made available to all members of the public for inspection and copying. The Department does not redact any information from these submissions. This means that personal information including names, phone numbers, addresses and similar information that a member of the public elects to submit to the Department and its commissions may appear on the Department's website or in other public documents that members of the public may inspect or copy.

**REAR YARD VARIANCE SOUGHT:** The proposal is to rebuild an existing garage and roof deck in-kind with a roof deck on the garage and a connection provided to the existing rear balcony of the primary building, plus a new stair from the roof deck to grade in the rear yard.

PLANNING CODE SECTION 134 requires that the property maintain a rear yard that is 30% of the lot depth. The proposed reconstruction of the garage, connector, and stair is located entirely in the required rear yard. Therefore, a variance is required.

**REAR YARD VARIANCE SOUGHT:** The proposal is to legalize the reconstruction of a rear building as an accessory home office.

PLANNING CODE SECTION 134 requires that the property maintain a rear yard that is 30% of the lot depth. The rear building is located entirely in the required rear yard. Therefore, a variance is required.

**1512 YORK STREET** Lot 046 in Assessor's Block 5514, in an RH-2 Zoning District, Bernal Heights SUD, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is to demolish an unauthorized deck expansion at the rear building and to construct a new deck expansion that will connect the two existing lower level decks.

PLANNING CODE SECTION 242 requires the subject property to maintain a rear yard of approximately 45 feet measured from the rear property line. The proposed

deck expansion will fall entirely within the required rear yard. Therefore, a variance is required.

**704 NORTH POINT STREET**, Lot 002 in Assessor's Block 0024, in a C-2 Zoning District, and a 40-X Height and Bulk District

**REAR YARD (LOT COVERAGE) SOUGHT:** The proposal is to demolish a portion of an existing one-story commercial building and construct a new four-story mixed-use addition fronting Columbus Avenue.

PLANNING CODE SECTION 134 requires no more than 80% of lot coverage at all levels containing residential uses. The proposal would result in the first and second floors covering approximately 84% of the lot. Therefore, a variance is required.

**REAR YARD VARIANCE SOUGHT:** The project proposes to legalize a three-story deck and stairs at the rear. The project includes a new room below the deck.

PLANNING CODE SECTION 134 requires that the subject property maintain a 30% rear yard of the lot depth, approximately 23 feet. The proposal extends nearly 20 feet into the required rear yard. Therefore, a variance is required.

**217-219 HOLLY PARK CIRCLE**, Lot 008 in Assessor's Block 5715, in an RH-2 Zoning District, Bernal Heights SUD, and a 40-X Height and Bulk District

**REAR YARD VARIANCE SOUGHT:** The proposal is to replace the existing, noncomplying exterior, rear stair with a new rear stair and deck structure.

PLANNING CODE SECTION 242 requires the subject property to maintain a rear yard of approximately 45 feet measured from the rear property line. The proposed stair and deck structure will fall entirely within the required rear yard. Therefore, a variance is required.

**(NICHOLAS FOSTER)**

**1400 MISSION STREET**, Lots 820-822 in Assessor's Block 3507 and Lots 001-190 in Assessor's Block 3507A, in a C-3-G Zoning District, and a 150-S and 200-S Height and Bulk District

**PUBLIC ART REMOVAL:** The proposal is to remove an existing mural at the subject property fronting 10th Street due to ongoing vandalism and graffiti to the subject artwork. The on-site artwork was installed to fulfill the public art requirement for the 100% affordable housing project that was approved by the Planning Commission in 2013, through Motion 18783 (Planning Department Record 2011.1043X). Planning Code Section 429 was recently amended through Ordinance No. 003-24 to authorize the Zoning Administrator to approve the removal, relocation, or alteration of artwork previously installed pursuant to Section 429 for 100% affordable housing projects.

Planning Code Section 429.4 requires the subject property to provide on-site public art of a value at least equivalent to the Public Art Fee. The proposal would remove the on-site artwork. Therefore, the project requires a duly noticed public hearing where the Zoning Administrator may approve, conditionally approve, or deny the removal, relocation, or alteration of the artwork.

**B. PUBLIC COMMENT:**

At this time, members of the public may address the Zoning Administrator on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator except agenda items. With respect to agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached in the meeting. Each member of the public may address the Zoning Administrator for up to three minutes.

The Zoning Administrator will not take action on any item not appearing on the posted agenda, including those items raised at public comment. In response to public comment, the Zoning Administrator may:

- (1) respond to statements made or questions posed by members of the public; or
- (2) request staff to report back on a matter at a subsequent meeting; or
- (3) direct staff to place the item on a future agenda. (Government Code Section 54954.2(a))

## ADJOURNMENT

### Hearing Procedures

The **Zoning Administrator** typically holds Variance Hearings on the **4<sup>th</sup> Wednesday of each month at 9:30 a.m.**, at the **San Francisco City Hall, Room 408**. City Hall is located at One Dr. Carlton B. Goodlett Place, San Francisco, CA 94102. Hearings are open to the public.

At the hearing, the **Project Sponsor** (Variance Applicant) will be given 5 minutes to present their case, including relevant testimony and evidence. The hearing room is equipped with a laptop and projector that can display photographs, architectural plans or other drawings and images. **Members of the public** will be given 3 minutes each to speak on the item. If a member of the public speaks against an item, the Project Sponsor will be given a 3-minute **rebuttal**.

Persons attending a hearing may comment on any scheduled item. When speaking, please note that a **timer** is used for each speaker and indicates how much time remains. Speakers will hear a notification indicating that the speaker's opportunity to address the Zoning Administrator is about to end or has ended.

Please note that some items may appear on the **Consent Calendar**. These items are considered routine and may be granted by the Zoning Administrator. There is no separate discussion of consent items unless the Zoning Administrator, member of the public or staff so requests, in which event the matter is removed from the Consent Calendar and will be moved to the Regular Calendar in the Agenda.

In addition, the Zoning Administrator may consider a request for **continuance** to a later date. He may choose to continue the item to the date proposed, to continue the item to another date, or to hear the item on this calendar.

After all the testimonies are submitted, the Zoning Administrator will consider the evidence, deliberate, and either make a decision, take the matter under advisement, or continue the matter in order for additional information to be presented.

Each hearing ends with **general public comment**, at which time members of the public may address the Zoning Administrator for up to 3 minutes on items of interest to the public that are within the subject matter jurisdiction of the Zoning Administrator, except agenda items. With respect to Agenda items, your opportunity to address the Zoning Administrator will be afforded when the item is reached during the meeting.

**Sound-Producing Devices Prohibited**

The ringing of and use of mobile phones and other sound-producing electronic devices are prohibited at this meeting. Please be advised that the Zoning Administrator may order the removal of any person(s) responsible for the ringing or use of a mobile phone, pager, or other similar sound-producing electronic devices (*67A.1 Sunshine Ordinance: Prohibiting the use of cell phones, pagers, and similar sound-producing electronic devices at and during public meetings*).

**Decision Letter and Appeal Process**

No decision is final until a **Variance Decision Letter** is issued. Due to current backlogs, decision letters may take **up to 2 months** to complete from the date of the hearing. The Zoning Administrator's action to grant or deny a variance application may be appealed to the Board of Appeals within **10 days** of the date of the Decision Letter. If any members of the public would like to receive a copy of the signed Variance Decision Letter via email, please send a request by email addressed to the Planner assigned to the case. The name of the Planner can be found in this Agenda, in the notice that you received in the mail, or in the poster posted on the subject property.

**Protest of Fee or Exaction**

You may protest any fee or exaction subject to Government Code Section 66000 imposed as a condition of approval in accordance with Government Code Section 66020. The protest must satisfy the requirements of Government Code Section 66020(a) and must be filed within 90 days of the date of the first approval or conditional approval of the development referencing the challenged fee or exaction. For purposes of Government Code Section 66020, the date of imposition of the fee shall be the date of the earliest discretionary approval by the City of the subject development.

The Zoning Administrator's approval or conditional approval of the development subject to the challenged fee or exaction as expressed in its Motion, Resolution, or Discretionary Review Action or the Zoning Administrator's Variance Decision Letter will serve as Notice that the 90-day protest period under Government Code Section 66020 has begun.

**Challenges**

Pursuant to Government Code Section 65009, if you challenge, in court, (1) the adoption or amendment of a general plan, (2) the adoption or amendment of a zoning ordinance, (3) the adoption or amendment of any regulation attached to a specific plan, (4) the adoption, amendment or modification of a development agreement, or (5) the approval of a variance, conditional-use authorization, or any permit, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Administrator or Planning Commission, at, or prior to, the public hearing.

**CEQA Appeal Rights under Chapter 31 of the San Francisco Administrative Code**

If the Zoning Administrator's or Commission's action on a project constitutes the Approval Action for that project (as defined in S.F. Administrative Code Chapter 31, as amended, Board of Supervisors Ordinance Number 161-13), then the CEQA determination prepared in support of that Approval Action is thereafter subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16. This appeal is separate from and in addition to an appeal of an action on a project. Typically, an appeal must be filed within 30 calendar days of the Approval Action for a project that has received an exemption or negative

declaration pursuant to CEQA. For information on filing an appeal under Chapter 31, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. If the Department's Environmental Review Officer has deemed a project to be exempt from further environmental review, an exemption determination has been prepared and can be obtained on-line at <http://www.sf-planning.org/index.aspx?page=3447>. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors, Planning Commission, Planning Department or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.

**Privacy Policy**

SF Planning is committed to protecting the privacy rights of individuals and security measures are in place to protect personally identifiable information (PII), i.e. social security numbers, driver's license numbers, bank accounts. Members of the public are not required to provide PII to the Commission or Department, as all written submittals and oral communications become part of the public record, which can be made available to the public for review and/or viewable on Department websites. Members of the public submitting materials containing PII are responsible for redacting said sensitive information prior to submittal of documents to Planning.
