Ramaytush Ohlone Acknowledgement

This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.

The Department does not redact any information from these submissions. This means that personal information including names, phone numbers, addresses and similar information that a member of the public elects to submit to the Department and/or advisory body may appear on the Department's website or in other public documents that members of the public may inspect or copy.

Accessible Meeting Information

LOCATION: 49 South Van Ness Avenue, San Francisco, CA 94103 is a public building and is wheelchair accessible.

TRANSIT: The closest transit stops are at Market Street and Van Ness Avenue, and on Mission Street between 11th Street and South Van Ness Avenue. MUNI lines serving the location are the 7 Haight / Noriega, 9 San Bruno, 9R San Bruno Rapid, 14 Mission, 14R Mission Rapid, 49 Van Ness/Mission, and the F Market & Wharves line. PARKING: Accessible curbside parking has been designated at points along South Van Ness Avenue and Mission Street. The closest public parking option is 1455 Market Garage (Propark) on 11th Street between Market Street and Mission Street. 49 South Van Ness can be accessed from the 11th Street entrance (wheelchair accessible).
