1. Announcements and Review of Agenda.
2. Review and Approve Minutes from the April 18<sup>th</sup> CAC meeting.
3. EN TRIPS Corridor Selection: Informational presentation by SFMTA staff and consultants regarding the Eastern Neighborhoods Transportation Implementation Planning Study (EN TRIPS), followed by discussion, comment, and potential action. Specifically, the presentation will focus on the process for selecting the three streets for which the team will focus its design work. At this time the City will be seeking the CAC's support for moving forward with the selected streets.
4. Capital Planning Prioritization: Showplace Square Open Space: Discussion of the appropriate location to fund new open space in Showplace Square, followed by

comment, and potential action. The discussion will include context for the process, and presentations of conceptual designs for two candidate locations: a new park on the Daggett Street right-of-way, and a widening of Jackson Playground.

5. Capital Planning Working Group: Monthly report back by this working group, followed by discussion, comment, and potential action.
6. Neighborhood Meetings: Discussion by staff and CAC members regarding the results of the May 14<sup>th</sup> neighborhood meeting in the Mission, as well as timing and logistics of the CAC's SoMa neighborhood meeting, followed by comment, and potential action. The Mission community meeting is scheduled for May 14<sup>th</sup>.
7. Historic Preservation Working Group: Monthly report back by this working group, followed by discussion, comment, and potential action. Discussion will include an update on the status of the Showplace/NE Mission Historic Survey.
8. Development Project Working Group: Monthly report back by this working group, followed by discussion, comment, and potential action.
9. Committee members' questions and comments.
10. Public Comment: At this time, members of the public may address the Citizens Advisory Committee on items of interest to the public that are within the subject matter jurisdiction of the Committee but do not appear on the agenda. With respect to agenda items, the public will be given an opportunity to address the Committee when the item is reached in the meeting. Each member of the public may address the Committee for up to three minutes.

Effective January 21, 2001, the Board of Supervisors amended the Sunshine Ordinance by adding the following provision: The ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at this meeting. Please be advised that the Chair may order the removal from the meeting room of any person(s) responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices (67A.1 Prohibiting the use of cell phones, pagers and similar sound-producing electronic devices at and during public meetings).

Hearings are held at the Planning Department, 1650 Mission St., Room 528, fifth floor, San Francisco, CA. The closest accessible BART station is the Civic Center station located at the intersection of Market, Hyde and Grove Streets. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Committee has closed the public hearing, your opportunity to address the Committee must be exercised during the Public Comment portion of the Calendar. Each member of the public may address the Committee for up to three minutes.

The Brown Act forbids a committee from taking action or discussing any item not appearing on the posted agenda, including those items raised at public comment. In response to public comment, the committee is limited to:

1. responding to statements made or questions posed by members of the public; or
2. requesting staff to report back on a matter at a subsequent meeting; or
3. directing staff to place the item on a future agenda. (Government Code Section 54954.2(a))
