Last Year – December 2023

- Impact Fee Deferral and Reduction Legislation (33% reduction in fees + 80% payment made at completion of construction)
- Ramifications: funding was proposed to be pushed out; no new projects

December 16, 2024

- Development projects still in holding pattern
- No area plan impact revenue this calendar year
- Expenditure Plan
 - Pushed expected revenue out
 - Don't anticipate adding new projects to roster
 - Priority of funding will be or projects ready to move forward

Legislation Update

- Legislation introduced by Mayor Breed and Supervisor Dorsey on November 5, 2024 [Board File No. 241087]
- The proposed Ordinance would amend the Planning Code to waive certain development impact fees in the Market and Octavia Area Plan (the Market and Octavia Area Plan and Upper Market Neighborhood Commercial District Affordable Housing Fee, the Van Ness & Market Affordable Housing and Neighborhood Infrastructure Fee, and the Van Ness & Market Community Facilities Fee.
- Scheduled to be heard at the Planning Commission next year.
