Banales: Sent to Mayor's office, BOS, Assembly, no response yet.

Presentation on Affordable Housing pipeline - (Lydia Ely, MOHCD Staff)

Levitt: What happened with RFQ with Parcel K?

Ely: In the pipeline, not financially feasible due to being in a low-resource area. CDLAC favors high-resource neighborhoods. State housing agency also not awarding funding

Parker: Federal financing?

Ely: CDLAC administers federal funds

IPIC Report Update - (Mat Snyder, SF Planning Staff)

Burdick: SF BOS cut/deferred impact fees for 3 years, have we measured if this has succeeded?

Snyder: One component to spur development, not a silver bullet.

Burdick: Did legislation have a sunset?

Snyder: 2029, not including deferrals.

Burdick: Residents should be included regarding access. How does it relate to improvement?

Banales: Multi-agency project.

Wilson: Ammel Park owns the parking lot. Police department put the fence up. Park on the north side of the fences is not well-cared for. Could open the fence during the day time. Kids walking to Ella Hill Hutch, have to walk on dangerous Laguna and Webster.
