1. CALL TO ORDER AND ROLL CALL

A quorum being present, the Chairman opened the meeting at 6:30pm.

2. Announcements, upcoming meetings and general housekeeping [discuss] (CAC)

- 2.1 Bicycle Injunction dropped. The court dismissed the injunction against the City as meritless. The City can now proceed on plans for safety of bicyclists throughout the City.
- 2.2 Curb cuts in Hayes Valley. The area between Laguna and Buchanan was mentioned.
- 2.3 Formula Retail [national/chain] stores: It was mentioned again that State Farm is trying to get into one of our developments on Gough St., against the policy for such stores. In the discussion, however, it was not certain that this policy would apply in this case. We need to clarify this.
- 2.4 **401 Grove/Gough.** This development will now offer affordable housing onsite.
- 2.5 2001 Market/Dolores. Their hearing will be before the Planning Commission. Prado is looking to acquire 55 Laguna property for offsite affordable housing.
- 2.6 1968 Buchanan/Market. They too have a hearing on the modifications to their development: they are eliminating car-sharing; they are arranging to substitute affordable housing to another site at Franklin/Market.

Acceptance of the minutes were moved, seconded (Levitt/Henderson) and unanimously approved .

Pipeline Report

Exhibit 3: Pipeline Report for November [Dischinger]

The report was accepted as presented. It was noted that a deck is evidently being added to a property on Fillmore Street.

Resolution on Inclusionary Housing policies for Market/Octavia Area

The resolution as presented was moved and seconded (Gold/Henderson).

Henderson then amended the motion, with Gold seconding it, to restrict or exclude 100-year (long-termed) leases and leased land in general.

The amended motion was unanimously approved, with Richards and Wingard being absent (Wingard arrived subsequently).

Finalizing 2010 CIP (Community Improvement Program) Recommendations and a process to update and augment M/O CIP projects list ("Appendix C") over time [act]

The discussion began regarding collisions map and intersection recommendations. The SFCTA will discuss their Central Circulation Study next month when they meet with us. We identified intersections which, indirectly or jointly, create problems for pedestrians: Church/16th Street; Haight/Fillmore; Oak/Octavia; Page/Laguna; Gough/Fell; Buchanan/Market.

At this point Wingard joined the discussion.

It was noted that the Living Alleyways program spent one-quarter of a million dollars (\$250k) to improve half a block! This requires some explanation. It is necessary to know what is the average cost of any Living Alleyway project (total and per block, with and without this extraordinary cost).

We discussed whether it was better to make a series of small grants or to wait for City departments to propose larger projects to us to partially fund. The consensus of the group was to fund green plantings as a category. It was noted that the City is only approving about 25 parklets (mini-parks/plazas) next year. If a street wants to pursue a Living Alley concept, then they must contact the Planning Department. The CAC concluded that the Living Alleys proposed by City departments are too complex and expensive. We preferred that neighbors assemble and propose these. In particular it was noted that maintenance of these living alleys is the most expensive and intensive factor in providing these amenities.

A motion to adopt this annual CIP update process was made, seconded (Levitt/Starkey) and unanimously approved.

7. CAC supplement to Monitoring Report and preparation for presenting this to the Planning Commission [act]

A discussion ensued on the revised report and missing executive summary. A few of the major trends noted were: 1) fee-out by developers and its impact; 2) Conditional Use permits; and 3) the transit capacity cannot absorb the predicted growth of the plan. The primary requirement of the Executive Summary is that it be clear, concise, and succinct. With that the revised supplement, awaiting the executive summary, was approved unanimously on a motion and second by Gold and Starkey.

The CAC agreed on Ken Wingard's suggestion that Section One of our CAC Supplemental Report has five topics (items enumerated refer to the order in the version discussed at this meeting):

- 1) New trends (items 3,5,6 & 8)
- 2) Inclusionary housing and fee deferrals (items 1 & 9)
- 3) MOP community (items 11,12 & 13)
- 4) Infrastructure/Development ratio and Bridge Loans (items 4 & 10)
- 5) Evaluating CU permits (item 2

Olsson will notify Richards of the CAC's requirements for the Executive Summary and the organization of the first section; then he will send him the approved revised supplementary report on which to base his Executive Summary. The report with its executive summary will be approved at the January 19th meeting and at that meeting the preparation for the presentation of the CAC's Supplemental Report to the Planning Commission will be refined.
