MEETING AGENDA:

1. Administration

- Meeting called to order: 6:02pm
- Levitt, Parker, Seigner present
- No quorum to approve prior minutes

2. 78 Haight St Project Presentation – (Honey Zaw, TNDC)

- Levitt: How many total units? Square feet?
TNDC: 64 units, parcel is 5,000 sqft.
Levitt: TNDC should consider Parcel K.
Hamilton: Parcel K is in MOHCD's pipeline of long-term development.
TNDC: TNDC was selected for R, S, and U. R and S were too expensive to develop.
- Parker: How many by lottery?
TNDC: 31 units by lottery, rest for transitional age youth.
TNDC: More than 1,100 applications for the 31 units.
- Parker: Was \$1M/unit cost due to the Faircloth Amendment?
TNDC: Primarily construction labor costs, plus pause in construction, and site logistics.
Levitt: What about modular housing?

TNDC: TNDC explored Type 1 (concrete), Type 3 (wood), plus modular. Type 1 was most cost efficient.

3. IPIC and Impact Fee Projections – (*Mat Snyder, Planning Department*)

- Levitt: Status of One Oak? Status of 30 Van Ness? Honda site?

Comment from OEWD: On hold.

4. Legislation - (*Jacob Bintliff, Office of Economic and Workforce Development*)

- Bintliff: Legislation proposed by the Mayor sunseting impact fees in the Market Octavia Plan area, and sunseting MO CAC.
- Seigner: What about offsetting the loss of impact fees for affordable housing?
Bintliff: The impact fees should be offset by the increase in housing production.
- Levitt: What about remaining freeway parcels?
Bintliff: MOHCD is evaluating all sites.
- Parker: If CACs are sunsetted, how will outreach happen with respect to up-zoning?
Comment from Hamilton: Outreach will continue through typical processes.

5. Next Meeting (*Dylan Hamilton, Planning Department*)

- Hamilton: September meeting cancelled. December meeting will be scheduled.
Levitt: Request for update from MOHCD on freeway parcels, and update on freeway commemoration.
Hamilton: Will ask MOHCD, and Planning, respectively.
