Dear Neighbor: You are invited to a neighborhood Pre-Application meeting to review and discuss the development proposal at 2201-2500 Bayshore Bl, cross_street(s) Raymond - Sunnydale (Block/Lot#: 5087-003/A, 5099-014,; Zoning:
Mixed-Use General, in accordance with the San Francisco Planning Department's Pre-Application procedures. The Pre-Application meeting is intended as a way for the Project Sponsor(s) to discuss the project and review the proposed plans with adjacent neighbors and neighborhood organizations before the submittal of an application to the City. This provides neighbors an opportunity to raise questions and discuss any concerns about the impacts of the project before it is submitted for the Planning Department's review. Once a Building Permit has been submitted to the City, you may track its status at www.sfgov.org/dbi.
The Pre-Application process serves as the first step in the process prior to filing a Project Application with the Planning Department. Those contacted as a result of the Pre-Application process will also receive formal notification from the city after the project is submitted and reviewed by Planning Department staff.
