Overview

Community Stakeholder Group

Purpose

- Develop and implement the Tenderloin Community Action Plan with Working Groups and City partners
- Advocate and mobilize community to ask for and justify resources for the Plan

Community Stakeholder Group

Who is a member?

- Only Tenderloin residents, community organizations, and businesses can apply
- There can be 15 members, 8 of which are residents
- Tenderloin community members can attend the meetings as a participant but only members can make recommendations

How are members identified?

- Community nomination
- Planning review
- Final decision by a selection panel of City partners with TL knowledge

Additional Information

- Members are trained before the CSG begins and during the first 3-6 months
- The CSG meets once per month

Nomination Process

These steps will lead to
the selection of the CSG
members.

Potential Selection Criteria to Determine CSG Members

- Resident seats could be determined by:
 - Experience with a Black, Native, or other people of color TL community
 - Expertise in a TCAP plan area
 - Received a nomination
- Community organization seats could include
 - Rep from each of the topic areas:
 - Housing and homelessness
 - Connections to care
 - Public realm and infrastructure
 - Invest in and celebrate people and culture
- Business seats at the CSG could include
 - At least one small business with 10 or fewer employees
 - At least one sole proprietor business
 - Maybe business with 50 or fewer employees

Working Groups

Purpose

- Collaborate with City agencies to define, clarify, and confirm TCAP actions and metrics
- Guide implementation

Working Group Topics

- *Housing Access & Houselessness*: SRO conditions and access, Supportive housing expansion, Shelter access and expansion
- *Connections to Care*: medical care, mental health care, and substance abuse support
- *Public Realm, Public Safety, & Infrastructure*: street & sidewalk safety and access; parks & open space, public safety
- *Invest in + Celebrate: People & Culture*: open space events; economic investments and support; arts & cultural experiences
