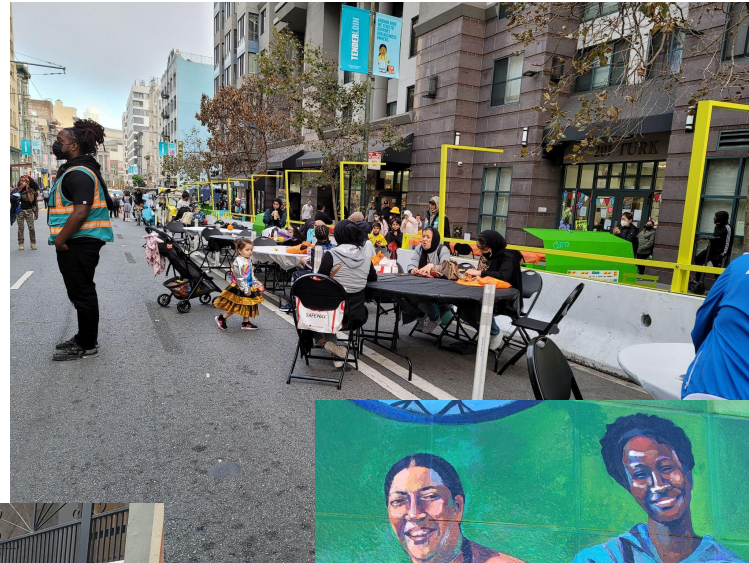


# Agreements

1. **Respect across the board** - Keep language simple and civil
2. **Inclusivity** - Holding a safe AND honest space for everyone to share and not withholding truths. **Stories stay, lessons leave** - Personal stories and self disclosures are not shared outside the meeting
3. **One Mic** - one voice at a time, no interruptions (write out your thoughts/questions so you don't forget)
4. **Listen to Understand** - Process first, repeat, and lastly, respond
5. **Follow Through** - Do as you say and respect deadlines and communicate if not able to
6. **Assume Good Intent** - Throw glitter not share
7. **Solution Contribution** - Provide solutions when challenging a recommendation. When you disagree, look for common ground or ideas you can work with and provide solutions
8. **Active Group Participation** - Be present, speak your truth and be engaged throughout the process
9. **Patience and Flexibility** - Plan with flexibility

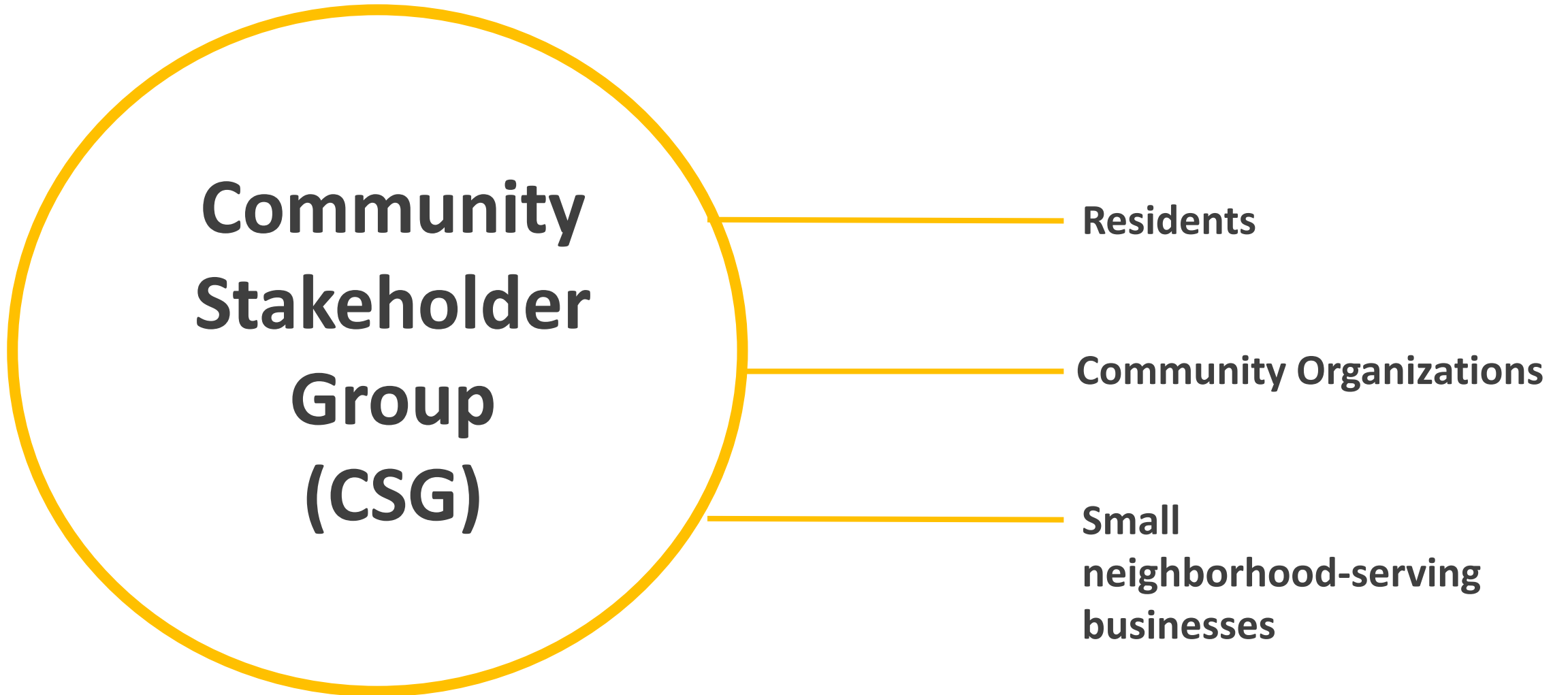

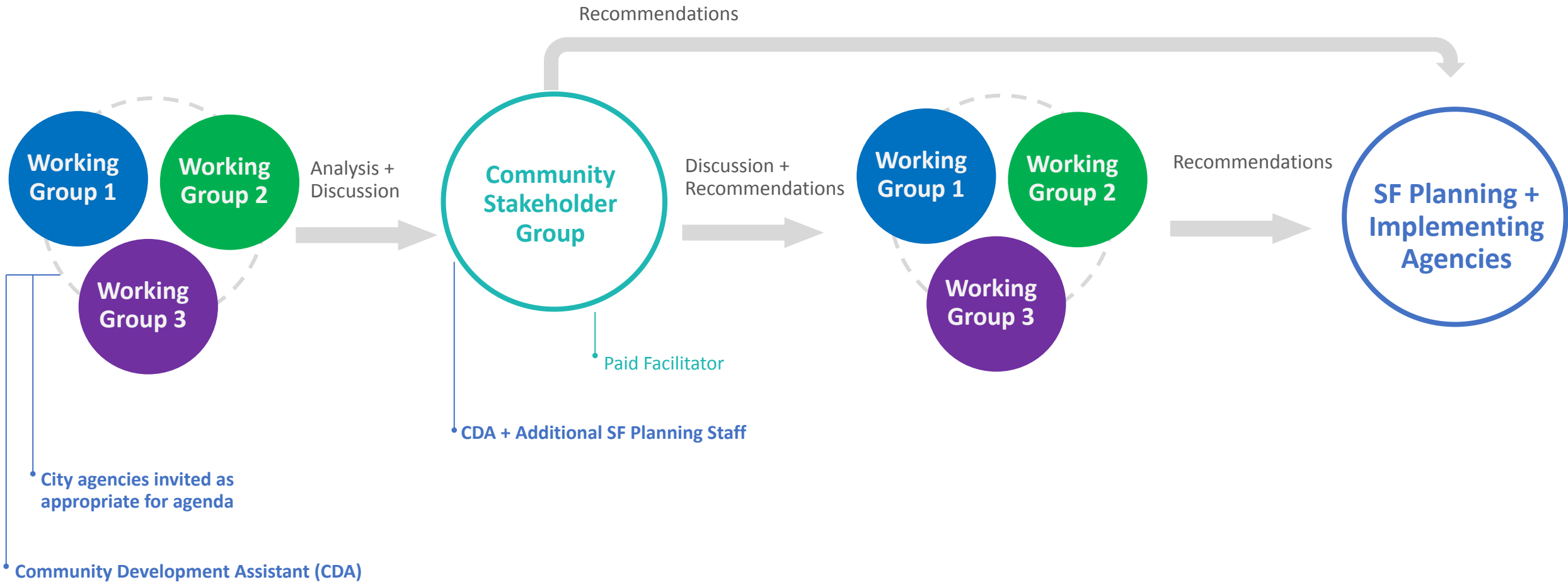
Tenderloin community organizing helped build the Tenderloin Community Action Plan

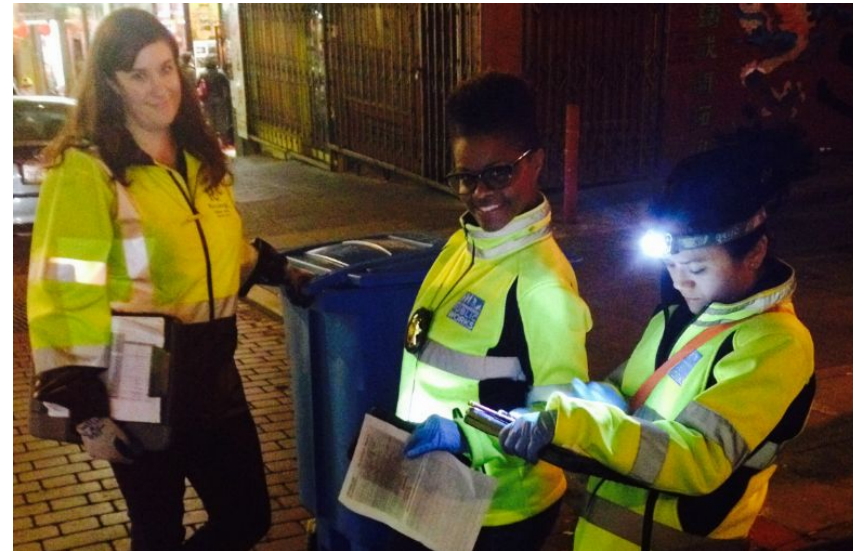

# The Community Stakeholder Group and its Working Groups will...

- Take the lead in a collective budgeting process, in which all of Tenderloin will vote on community projects
- Review the Tenderloin Community Action Plan, prioritize actions in the Plan, share recommendations for *how* the project can be done to best serve residents
- Work with representatives from other city agencies

# Important to Know

- The Community Stakeholder Group will meet once a month, likely for the next three years. This is a marathon, not a sprint!
- Residents who are not here on behalf of organizations will receive a stipend.
  - There are only a certain number of stipends.
  - Stipends will be gift cards to grocery stores until cash gift cards are possible.
  - \$25- \$30 gift card per meeting
- Planning Department will send emails and Outreach & Equity Team will send texts to remind us of meetings
