### **About SF Survey**

The San Francisco Citywide Cultural Resources Survey (SF Survey) is a multi-year program to identify and document places and resources of cultural, historical, and architectural importance to San Francisco's diverse communities. SF Survey brings together efforts to inform the Planning Department's work on land-use decisions, environmental review, building permit applications, landmark designations, and cultural heritage initiatives. SF Survey efforts are guided by collaborations with community partners, historic preservation peers, culture bearers, and community members.

### Who decides which places are important and should be preserved for future generations?

Community members, community historians, and knowledge bearers have a central role in identifying and interpreting the places that hold meaning to their communities. The San Francisco Planning Department is tasked with gaining an understanding of the historic, architectural, and cultural associations of buildings and places in our city. To ensure knowledge of what is meaningful to communities guides their work, staff collaborates with community partners, including Cultural Districts, the San Francisco Public Library, and cultural and history advocacy organizations.

## How do we learn about important places in our city and their meaning?

San Francisco is a dynamic place, home to diverse communities and a rich network of organizations and institutions engaged in cultural and history advocacy efforts. Knowledge about important places in our city and their meaning is actively shared through public programming, community-led efforts, and archives. Another way we learn about important places is through the Planning Department's SF Survey program and the *Citywide Historic Context Statement*. This information is documented in the SF Cultural Heritage digital platform and San Francisco Property Information Map. Additional efforts to preserve important places include the Landmark Designations Program, the historic resource review process for new projects, and cultural heritage initiatives.

#### Why do SF Survey efforts matter?

The information gathered through SF Survey facilitates the historic resource review process for the California Environmental Quality Act (CEQA), building permit applications, new development projects and area plans, and guides work on landmark designations. SF Survey efforts support community-led cultural initiatives through partnerships, programming, research, and historic preservation protections and initiatives. For example, the Church for the Fellowship of All Peoples (2041 Larkin Street) was identified as an eligible landmark in the African American Citywide Historic Context Statement. SF Survey partnered with church leadership and congregation members to designate the property and in 2023, the church became the City's 309th landmark.

## What are the steps that lead to identifying places of cultural, historical, and architectural importance through the SF Survey program?

- Step 1: Gather information. Staff review information in the *Citywide Historic Context Statement*, past documentation and unadopted surveys, the San Francisco Property Information Map (PIM), and Assessor records.
- Step 2: Conduct fieldwork. Staff survey buildings, structures, objects, districts, and sites with an unknown historic status that were constructed 45 years ago or older (ageeligible). From the public right-of-way, staff take photographs and study building modifications. Local community organizations and the public are informed about ongoing efforts.
- Step 3: Research and evaluation. Staff
  undertake additional research for historic and
  cultural resources and provide initial evaluations
  for the places surveyed. Considerations include
  architectural qualities, as well as associations
  with important people, organizations, events, or
  traditions that contribute to our national, state, or
  local history or cultural heritage. Local community
  organizations and the public are invited to learn
  more about SF Survey and share their knowledge.
- Step 4: Review and adoption of "living" findings. "Living" findings include the identification of places that appear eligible for listing in the California Register of Historical Resources. Local community organizations, community partners, community members, senior preservation planners, District Supervisors, and the Historic Preservation Commission are involved in the review of findings. Owners, occupants, and stewards of buildings and sites surveyed are notified and also involved. With community input, the Historic Preservation Commission adopts the findings.



## What happens once SF Survey "living" findings are adopted by the Historic Preservation Commission?

SF Survey "living" findings continue to be updated as new information is shared and through community engagement. After the adoption of findings, Planning Department staff:

- Integrates new information in San Francisco Property Information Map and SF Cultural Heritage (public digital resources);
- Updates "living" findings and keeps track of new information shared through active community engagement and public programming opportunities; and
- Recommends places for the local historic register as City Landmarks, through Article 10 of the San Francisco Planning Code.

### What is the Landmark Designations Program?

This program is an effort to locally designate important places as City Landmarks which have been previously identified as historic through the *Citywide Historic Context Statement*, SF Survey, and/ or other past survey efforts. The program prioritizes the designation of places which are most vulnerable and have property owner and community support.

### What is the process to nominate a City Landmark?

Landmark designations are initiated by the Historic Preservation Commission or the Board of Supervisors. Anyone is welcome to submit a landmark designation application or suggest important places for consideration as San Francisco landmarks. Please contact **CPC**.Landmarks@sfgov. org with questions.

### Where is SF Survey fieldwork happening?

Since 2023, the SF Survey team has prioritized fieldwork in Neighborhood Commercial Districts. In 2025, staff started fieldwork in residential areas, beginning with the Sunset neighborhood. ## My building or site has been identified as historic. What does this mean, and do I need to take any action?

A historic building or site can continue to be used, maintained, repaired, and adapted. Some changes will require review by a preservation planner to ensure important qualities are preserved. The purpose is to ensure the building or site continues to contribute to our understanding of San Francisco's history and is shared with future generations. Important places determined as eligible for listing on local, state, and federal historic registers may qualify to apply for preservation incentives. https://sfplanning.org/preservation-incentives
