(Updated as of December 1, 2024, rates effective as of January 1, 2025)

## Introduction

An impact fee is a fee that is imposed by a local government on a new or proposed development project to pay for all or a portion of the costs of providing public services to the new development. Impact fees are considered to be a charge on new development to help fund and pay for the construction or needed expansion of offsite capital improvements. These fees are usually implemented to help reduce the economic burden on local jurisdictions that are trying to deal with population growth within the area. Most of the City's Development Impact Fees will be increased by 2 percent annually in accordance with San Francisco Planning Code Article 4, Section 409(b). The new fee register will be posted on December 1st each year and effective on January 1st. The adjusted fee rates apply to development impact fees paid on or after the effective date of any such fee adjustments, regardless of the date of permit filing or issuance of the preliminary fee assessment rate as shown on DBI's Citywide Development Fee Register for the particular project.
